Program Information:

Please **dress in scrubs** and bring to class all materials on the program requirements checklist, including your textbook and the booklet from the OSBN - *Being a Nursing Assistant in Oregon*. Also, please bring a lunch. Refrigerators and microwaves are located in the student lounge and provided for your convenience.

All required clinical items (see below under clinical requirements) must be completed and delivered to the school two (2) business days prior to the first day of class. If all clinical required items are not handed in on time, clinical placement may be affected and the student may not attend a clinical rotation until these items are taken care of. These items are required by law from the Oregon Health Authority.

Also required for attendance in the clinical rotation: All required time in the class and lab is completed per OSBN regulations. And, you have passed the final written exam (required minimum score for passing is 80%).

CNA-2 DAY CLINICAL SCHEDULE

Clinical Requirements: To attend the clinical rotation it is the student’s responsibility to provide the following information. Per the Oregon Health Authority no student will be allowed in the clinical setting until the school office has received and verified all documentation is accurate and give the required info.

The following is a list of the required items for clinical attendance:

1. You have provided the office with the correct BLS CPR card (American Heart Association BLS only)
2. A two-step TB test has been completed and all test results are verified by the office (if TB PPD is positive then a Quantiferon blood test or a chest x-ray with a negative test result is acceptable)
3. Drug screening is completed and the office has received the results
4. You have submitted your immunization record that includes:
 - i. MMR
 - ii. HEP. B
 - iii. TDAP
 - iv. Varicella (or history of chicken pox)
 - v. Current flu vaccine (during flu season)
