Clinical Required Items:

**All clinical eligibility documentation must be completed, submitted, and confirmed by the school business office five (5) business days prior to the first day of class or the student will be removed from their scheduled clinical rotation and moved to a wait list to go into the clinical setting.**

The clinical required items are as follows:

- **Substance Abuse Screening: \$60** Drug screening ONLY AVAILABLE through the school's service provider.
- **AHA BLS CPR Card:** Sign-up for CPR class at the school or submit a current AHA BLS CPR card to the business office.
  1. **\$65/AHA BLS CPR Class** (If you do not have a current AHA CPR BLS card you must sign up for a CPR class during your registration process.)
  2. **CPR classes scheduled through the school must be completed prior to the beginning of the student's clinical rotation.**

### CNA-2 DAY CLINICAL SCHEDULE

**The following is a list of the required items for clinical attendance:**

**Please note: the TB test and the drug screening must be done before the start of class and handed into the office no later than 2 business days prior to class starting. The drug test can take a week for results to be sent to the office.**

1. **American Heart Association BLS CPR card.** Must be current and cannot expire during program. *A CPR class attended at the school prior to the clinical is allowed for clinical attendance.*
2. **A two-step PPD TB skin or Quantiferon blood test** that shows a negative result. If the test shows a positive result, then a chest x-ray with a negative test result must also be obtained.
3. **Drug screening** completed 1 week before class begins. The office will receive the results from the lab.
4. **Immunization record** that includes:
  - i. **Covid-19 Vaccine (must be fully vaccinated)**
  - ii. **Current flu vaccine (during flu season)**
  - iii. **HEP. B**
  - iv. **MMR**
  - v. **TDAP**
  - vi. **Varicella (or history of chicken pox)**
